# **Terms and Conditions**

# **Cancellation and modification policy**

Cost and restrictions related to court reservation

Pickleball court reservations can be made via the **Outaouais Pickleball Club** website (<u>https://www.clubpickleballoutaouais.com/</u>). A guide explaining the steps to follow will be available soon.

**Member** and **non-member rates** as well as the non-member surcharge are posted on our website and may vary without notice.

A maximum of four (4) players per court is authorised.

A maximum of **one guest** (non-member) per **member** applies for all reservations paid at the **member rate**. A **non-member surcharge** must be paid before the start of the reservation and a maximum of **two guests** are allowed to join **two members**.

If the **reservation is made by a non-member**, the **non-member rate** applies to the reservation. No refund will be given if a member is part of the group (maximum 4 players per court).

If the **reservation is made by a member**, the **member rate** applies to the reservation and allows **four members** to play at no extra charge.

If the **reservation is made by a member** and **one of the players is not a member**, the **member rate** applies to the reservation but the **non-member surcharge** must be paid before play starts. A **member** may invite a **non-member** to play. If **two members are** in the group, **two non-member players** may accompany them. The **non-member surcharge** applies only once to the member rate.

# **Pricing policy**

### **PRICING POLICY** - Maximum of four player per court. - One guest (non-member) per member. - A non-member surcharge must be payed before playing if at least one of the guest (non-member) is part of the group. - Each player must sign the disclaimer waiver. ### **Refund Policy**

### Modification or cancellation of a reservation after it has been placed

If you need to make changes to a reservation, please contact customer service as soon as possible by e-mail at **info@clubpickleballoutaouais.com** or by phone at **(873) 456-0316**, clearly indicating your reservation number and the changes you wish to make. We will do our best to accommodate you.

The current refund policy applies as follows:

#### **MEMBER**

- All cancellations will be credited to the member's account.

#### NON-MEMBER

- Cancellations made **more than 24 hours before the start of the rental period** will be refunded with a **\$5.00 fee to** cover administrative costs.
- Cancellations made less than 24 hours before the start of the rental period are non-refundable.

### Subscription fee refund (membership card)

Subscription fees for membership cards (CPO or ARPO-CPO) are **refundable up to 48 hours after the date of purchase.** After 48 hours from the date of purchase, **no refund will be granted**.

If you wish to cancel your membership, please contact customer service as soon as possible **within 48 hours of the purchase date**, either by e-mail at **info@clubpickleballoutaouais.com** or by telephone at **(873) 456-0316**, indicating your **full name**, **telephone number** and **membership card number**. A member of our team will deal with your request.

In consideration of the acceptance of my enrollment in the activities and/or programs offered or sponsored by the **Outaouais Pickleball Club**, I, hereby, acting for myself, my heirs, assigns, administrators or other persons who may purport to act on my behalf, waive, release and discharge the **Outaouais Pickleball Club** and any person acting on its behalf from any and all liability and agree not to sue for any injury, illness, loss of life or property damage of any nature whatsoever arising out of, or sustained in connection with, my participation in any of the Company's activities. This waiver and release applies to all claims, foreseeable or unforeseeable, including those involving negligence or breach of statutory duty (including those covered by the Occupier's Liability Act).

I understand that this release is intended to be as broad and inclusive as permitted by law. # **Rules and Policies**

The **Outaouais Pickleball Club** is a company that promotes the well-being of all its members and customers. Implementing and enforcing policies and regulations is an issue of great importance to us.

In order to eliminate grey areas and ensure that your visits to our facility run smoothly, we would like to share the policies and regulations that are in place.

- 1. Courts access is reserved for players.
- 2. You must **show your CPO membership card** at the reception desk before using the pickleball courts.
- Sport shoes are mandatory. Only sport shoes with non-marking soles are allowed on the pickleball courts and in the facility. <u>Boots, outdoor shoes must be left at the</u> <u>entrance. Coats can be left at the entrance, reception or in one of the changing</u> <u>rooms</u>.
- 4. Sportswear mandatory (T-shirt, tank top, shorts, pants, skirts).
- 5. Shirtless play is **prohibited**.
- 6. **No Food** allowed on the courts.
- 7. Water bottles are permitted on the courts.
- 8. Users must **respect the equipment and courts**. Aggressive use of rackets, balls or other equipment may be sanctioned to ensure the safety of other players.
- 9. Users must **respect allotted playing times**. Play time begins and ends **on the hour.** After the allotted time (10 minutes *if court availability permits*), users will be charged an additional hour's rental at the current rates.
- 10. You must use respectable language on the pickleball courts and on the premises of the **Outaouais Pickleball Club**. The use of vulgar, aggressive, intimidating or disrespectful language will not be tolerated. Such behaviour may lead to **expulsion without refund**.
- 11. Debris and small rocks get lodged in the soles and damage the surface of the courts. Shoes with non-marking soles are mandatory to play on Outaouais Pickleball Club courts. The soles must be free of dirt and debris. You may have to change shoes or stop playing if they do not meet standards.
